Our Christian Training Center director in southern India is Pastor J.T. Norman. We have worked together for many years. The following report should encourage your heart and reassure you in your support of this ministry. God is using CTC grads worldwide!

In the **12 months of 2014**, our graduates' year-end reports have shown that **6,943** new souls have received Jesus into their hearts as their Lord and Savior. This report is **from 274 graduates** of Sonshine School of Ministry (**our CTC program**). I believe that when we receive reports from all of the **378 graduates**, the number of people who received Jesus as their Savior will be much more. Just this week **46** people received Christ as their Savior in our local CTC student ministry. Our reports indicate that of the **378 graduates**, only **7%** (about 26 graduates) are not involved in ministry. **There is an open door filled with hungry hearts! Let us win them for King Jesus and expand His Kingdom!**

N. Vincent Raj (wife – Mary) When my village was reached by Sonshine Ministries with the Gospel, I was a troublemaker. I did not want my father to worship Jesus. In order to stop them from coming to my village, I used to let the air go from the pastor's motorcycle's tires in addition to other mischievous things.

Now I look back at what the Lord has done in my life. Once I was under the influence of Satan 24/7 and now I am under the influence of the Spirit of the living God because Sonshine Bible School (our CTC program)

students and pastors obeyed the Lord. Now I am not only a brand new man in Christ; I am a minister of God. I thank the Lord for Sonshine Bible School and its ministries.

I used to think that because of my former mischievous things, God would think twice before blessing me with a motorcycle or blessing me with anything for His ministry. I was wrong. God proved His love and His will by blessing me with this motorcycle to further His work.

Now I am ministering in a village named Sathanoor. We (CTC Bible school students) reached this village with the gospel and now we have a church there. People in this village worship Satan as their god. We are literally bringing people from bondages of Satan into blessings of the Savior Jesus Christ. Now there are 30 people who are saved and filled with the Holy Spirit worshipping with us. We are also conducting weekday Bible study in 4 new villages that are 30 miles away from us.

Please pray that we will continue to bring people from darkness into His marvelous light in spite of all the problems and persecution that try to threaten us from going forward. Blessings!



B. Markraj (wife - Shanthi) I was brought up in the Sonshine orphanage through my 12th grade. After graduating from high school, I

realized the call of God in my life for His ministry. However, I was trying to ignore the Lord's calling for I thought that I should be a police officer. After a long battle, I obeyed the call of the Lord and joined in Sonshine School of Ministry (CTC program) to get the proper training to become a minister for the Lord. After grad-

uating from the Bible school, I got married to Shanthi and took over a newly planted church in Paravai village. In the last 3 years we were able to share the Gospel in Paravai village and the surrounding **16 villages**.

Everyday is an adventurous day as anything can happen any time in this predominantly Hindu area. By the grace of God, we have **35 people** worshipping with us every Sunday. Twenty-seven are filled with the Holy Spirit and 32 have obeyed the Lord in water baptism.

Recently, I had a marvelous experience of protection of the Lord when I shared the Gospel in a village 30 km from Paravai. When I gave the alter call, **7 people gave their hearts to the Lord** and confessed Jesus as their Lord and Savior. Ninety percent of these villagers are Muslim. Without warning, some people from the village started stoning me, saying there is no God other than Allah.

When I realized there was no escape from this angry group, I knelt down and prayed in a loud voice, saying, "Jesus you said that you would protect and keep when I am in trouble. Because I am in covenant relationship with you through your blood covenant and I have your surname like Abraham, I claim my freedom which is in your Name." As I continued to pray, I claimed everything which I learned from my Covenant class in the Bible school. I was a good student in the Bible school.

While I was still praying, a man from the crowd cried, **"Stop stoning, this is God man; I know all about covenant and the covenant keeping God. If we don't stop persecuting this man his God will fight for him, so let him go."** Then they stopped and nursed my wounds, gave me tea to drink, and saw me safely back to my village. Before leaving, I was able to share another 15 minutes about Jesus and His blood covenant. The village chairman said that I am free to come and go, saying that this man is not a threat to our villagers. **Prayer works!** Our God is the same God of Abraham, Isaac and Jacob. Amen!
