My passport is still at the Nigerian Embassy in Washington DC. However, I did get a call from my Nigerian friend who is going to pick it up when ready, that he was contacted to let us know that it should be ready soon. I pray so, as there is so much to do.

That being the continuing situation, I wanted to continue with a second edition taken from my favorite periodical, *Zion's Fire*. As I indicated last month, I will continue with excerpts from David Rosenthal's article entitled, "Is this the dawn of a New World Order?" Quotes from David will be in this color, normal print black color will be my paraphrase from the article, and my personal comments will be in this color.

Only months ago, the United States was riding high. We were reveling in the dynamism of our economy... And yet, in the short span of a few months, it has all but vanished. The global response to the pandemic has revealed a massive seismic fault in the integrated global financial system... Consider for a moment the multitude of ways in which our daily lives have been restricted and reshaped. Ways that were unthinkable prior to the pandemic. Many have suggested our response to the pandemic further eroded our freedoms.

There is a deeply entrenched cabal of wealthy elitists attempting to create and control a worldwide digital

medical system for the purpose of implementing mandatory vaccines and biometric initiatives in what has been termed "Pharmaceutical Tyranny." Many governments have embraced these medical initiatives as cover for gaining more control over their citizenry.

We are witnessing the rise of "Technocratic Tyranny" where those who are to rule are selected on the basis of their area of expertise such as science, health, or technology. Today...It is a sinister trend within governments that seeks to control entire populations through the use of high tech surveillance, monitoring, and tracking. Technology continues to advance at seemingly unprecedented rates with every new advancement being surpassed by the time it is put into distribution. We often do not take the time to consider where such "advancements" are leading us or what are the negative consequences of the "latest and greatest" new thing.

For the past few years, many economists and political experts were predicting some sort of "global reset" due to economic stagnation, massive debt, changing demographics, the rise of communist China, and a host of other issues.

**Some History:** Agreements that reshaped our world after WWII formed our current economic system. The USA ushered in a new financial system that defined the U.S. dollar as the world's standard reserve currency... The U.S. funded a financial recovery plan that essentially amounted to a "free global trade agreement." By guaranteeing shipping safety on the open seas. This allowed devastated nations to grow via selling their goods to the USA without high tariffs. With one important caveat: The nations must side with the U.S. in its ongoing conflict with communism—more specifically Russia. Since WWII the world has experienced 7 decades without any major world wars.

...In 1991, the infamous "Cold War" ended with the dissolution of the Soviet Union. Europe no longer felt the threat of communism and in 1993 formed the European Union (E.U.) creating a political and economic system to rival the U.S.A.

**The Trump Presidency:** From the beginning, Donald

Trump declared he would “Make America Great Again” and determined to put the U.S. First in global negotiations. He has cancelled trade and military agreements with nations who have taken advantage of weak U.S. leaders, and shirked their responsibilities to the U.S. far too long. His actions shocked many, but it has also paved the way for the President to successfully renegotiate bilateral agreements with several crucial trading partners around the world to the benefit of America’s citizens.

### **China & The World Trade Organization (WTO)**

China entered the WTO in 2001 and given “developing nation status” providing it major trading advantages. However, China has continuously devalued its currency to keep prices of its goods below other nations. It also subsidizes major Chinese businesses giving them unfair advantage over their global competition. China’s economy rocketed, doubling its GDP every 8 yrs.

...The Trump administration made a series of strategic, legal moves over the past two years to essentially encourage the dissolution of the WTO. As of December 2019, the WTO...has been rendered impotent.

**Detaching from China:** ...the U.S. is detaching from China as it seeks to bring manufacturing back to America’s shores... It is quite possible we are in the process of moving from a unipolar world (with the U.S. as the only superpower) to a multipolar world (with 3 to 5 dominating regional powers).

**The Prophetic Perspective:** ...the crucial question is, What will happen to the nations of the Middle East? If Muslim states... find themselves on the outside of the world’s major trading blocs, they may determine their only course of action is to unite by forming an economic and religious bloc (an Islamic caliphate) of their own... **The prophetic Scriptures make it clear that in the last days, a ten-nation confederation will arise referred to in the Bible as the Beast.** The kings of these 10 nations will acquiesce, and give their power to one who will rule over them—Satan’s progeny—the Antichrist (**Daniel 2 & 7; Revelation 17**). He will demand the worship of both Jews and Christians living within his realm and require all to receive his mark; “The Mark of the Beast” (**Rev. 13:16-17**)

If the U.S. withdraws its longstanding support for the Jewish state—whether it be through a new global order

or due to a change in American leadership—the stage could quickly change in favor of Israel’s surrounding enemies. Is this the dawn of a “new world disorder” catapulting us toward the last days, the rise of Anti-christ, and the glorious return of Jesus Christ? Only our sovereign Lord knows the answer to this question. As believers, we are simply called to watch and be ready. The end of David’s article.
